APPLICATION

Roundup Ready Herbicide with PLANTSHIELD by Monsanto offers enormous flexibility. It delivers the convenience of treating weeds whenever they become a problem.

All applications must comply with the application guidelines on the Roundup Ready Herbicide with PLANTSHIELD by Monsanto label. Care also needs to be taken to ensure the correct seed is planted into the appropriately designated field. Roundup Ready Herbicide with PLANTSHIELD by Monsanto will have a broad spectrum weed control effect on conventional cotton crops.

Roundup Ready Herbicide with PLANTSHIELD by Monsanto may be applied to Roundup Ready Flex cotton crops as an over-the-top application from emergence through to 22 nodes. At this stage, up to four applications can be made (maximum of 1.5kg/ha per application). A pre-harvest application can be made once the crop has reached 60% boll open stage, however the total amount applied per season must not exceed 6.0kg/ha.


Key points:

- Total of all applications in any one crop must not exceed 6.0kg/ha.
- Up to 4 applications may be made over-the-top in any one crop.
- Any single application must not exceed 1.5kg/ha.
- A single application may occur between 60% boll open and harvest.

A combination of residual herbicides and other weed control techniques should be used as part of a balanced weed management program.
