

Roundup Ready PL Herbicide with PLANTSHIELD is formulated with proprietary surfactant technology for superior performance and the PLANTSHIELD crop safener to provide users with the same excellent efficacy and crop safety of the trusted Roundup Ready Herbicide with PLANTSHIELD granule, but with the added convenience of reduced handling of a liquid formulation.

## **PROVEN PERFORMANCE**

Roundup Ready PL Herbicide with PLANTSHIELD has demonstrated performance equivalent to the granule on a variety of weed species including Wild Radish and Glyphosate-Resistant Sow Thistle.

## **APPLICATION**

Target the first application of Roundup Ready Herbicide with PLANTSHIELD and Roundup Ready PL Herbicide with PLANTSHIELD on young canola with weeds less than 6 cm in size. Select the spray timing based on the most difficult to control weed species in each field. Ensure broadleaf weeds have at least one true leaf and grasses have at least two true leaves before application.

To maximise yield, a second application may be required provided the applications are separated by at least 14 days. The first spray minimises competition on the crop by early removal of weeds, the second reduces grain sample contamination and weed seed set by spraying at the latest opportunity.

## **Key points**

- Applications can be made from crop emergence to 6 true leaf stage (prior to bud formation).
- Up to 2 applications can be made in any one crop.
- Each application must be 0.9 kg/ha (Roundup Ready Herbicide with PLANTSHIELD) or 1.15 L/ha (Roundup Ready PL Herbicide with PLANTSHIELD) with a water rate of 50-80 L/ha.
- All applications must be made according to label directions.
- Only use tank mix partners that are on the Roundup Ready Herbicide label.
- Use a coarse spray pattern to reduce off-target drift.
