



## DIRECTIONS FOR USE

#### **Restraints:**

DO NOT apply to Couch Grass greens in the period April-September, or when Couch Grass is near dormancy. DO NOT use KELPIE® PROCYM 800 WG FUNGICIDE in the home garden.

#### **GENERAL INSTRUCTIONS**

#### Phytotoxicity

KELPIE® PROCYM 800 WG FUNGICIDE may cause discolouration and reduced growth of colonial bentgrass cv browntop. KELPIE® PROCYM 800 WG FUN-GICIDE is phytotoxic to couch grasses when they are approaching dormancy or are in a semi-dormant state and especially under cold very wet soil conditions. The phytotoxicity may result in scorching, reduced growth and loss of turf through wear. Avoid using KELPIE® PROCYM 800 WG FUNGICIDE on couch greens within the period April to September. When used as directed, KELPIE® PROCYM 800 WG FUNGICIDE may cause slight and temporary discolouration of hybrid couch cv Tifgreen and other Tif-related varieties.

#### Mixing

KELPIE® PROCYM 800 WG FUNGICIDE is suitable for application through conventional spray equipment calibrated to ensure thorough crop coverage. Add the required amount of KELPIE® PROCYM 800 WG FUNGICIDE to the partly filled tank with the agitator running and complete filling the tank with water. DO NOT mix with alkaline water. Continue thorough agitation during spraying and after a stoppage. DO NOT let prepared spray solution sit in spray tank overnight.

#### **Dilute Spraying**

- Use a sprayer designed to apply high volumes of water up to the point of run-off and matched to the crop being sprayed.
- Set up and operate the sprayer to achieve even coverage throughout the crop canopy. Apply sufficient water to cover the crop to the point of run-off. Avoid excessive run-off.
- The required water volume may be determined by applying different test volumes, using different settings on the sprayer, from industry guidelines or expert advice.
- Add the required amount of KELPIE® PROCYM 800 WG FUNGICIDE specified in the Directions for Use table for each 100 L of water. Spray to the point of run-off.
- The required dilute spray volume will change and the sprayer set up and operation may also need to be changed, as the crop grows.

#### **Concentrate Spraying**

- Use a sprayer designed and set up for concentrate spraying (that is a sprayer which applies water volumes less than those required to reach the point of run-off) and matched to the crop being sprayed.
- Set up and operate the sprayer to achieve even coverage throughout the crop canopy using your chosen water volume.
- Determine an appropriate dilute spray volume (see Dilute Spraying above) for the crop canopy. This is needed to calculate the concentrate mixing rate.
- The mixing rate for concentrate spraying can then be calculated in the following say:

#### EXAMPLE ONLY:

- 1. Dilute spray volume as determined above: for example 1500 L/ha.
- 2. Your chosen concentrate spray volume: for example 500 L/ha.
- 3. The concentrate factor in this example is: 3X (that is, 1500 L divided by 500 L = 3)
- 4. If the dilute late rate is 6 g/100 L, then the concentrate rate becomes 3 x 6 g, that is, 18 g/100 L of concentrate spray.
- The chosen spray volume, amount of KELPIE<sup>®</sup> PROCYM 800 WG FUNGICIDE per 100 L of water, and the sprayer set up and operation may need to be changed as the crop grows.
- DO NOT use a concentrate rate higher than that specified in the Critical Comments.
- For further information on concentrate spraying, users are advised to consult relevant industry guidelines, undertake appropriate competency training and follow Industry Best Practices.

## Wetting Agent

Add a wetting agent at the rate of 10 mL/100 L (600 g/L product e.g. Agral® 600) of spray. With hard to wet crops the rate may be increased to 20 mL/100 L.

## COMPATIBILITY

KELPIE<sup>®</sup> PROCYM 800 WG FUNGICIDE is compatible with the following products: Agral<sup>®</sup>, Ambush<sup>®</sup>, Imtrade Pirimicarb 500 WG Aphicide, Omite<sup>®</sup>. Provided the spray tank has an adequate agitation system and the mixture is not allowed to stand without agitation, these mixtures are acceptable. Some

settling will occur with mixtures of Omite® and Ambush®.

Some naturally occurring individual fungi resistant to KELPIE® PROCYM 800 WG FUNGICIDE or any other Group 2 Fungicides may exist through normal genetic variability in any fungal population. The resistant individuals can eventually dominate the fungi population if these fungicides are used repeatedly. These resistant fungi will not be controlled by KELPIE® PROCYM 800 WG FUNGICIDE or other Group 2 Fungicides. Since the occurrence of resistant fungi is difficult to detect prior to use, Sinochem International Australia Pty Ltd accepts no liability for any losses that may result from the failure of KELPIE® PROCYM 800 WG FUNGICIDE to control resistant fungi.



## PRECAUTIONS

## **RE-ENTRY**

DO NOT enter treated areas for the period after spray application shown below unless wearing the specified protective equipment:

Beans, Potatoes, Lentils, Canola and Turf: Until the spray has dried.

Stone Fruit, Grapes (Harvest only): Until the spray has dried.

Stone Fruit (thinning): 14 days.

Grapes (grape girding and cane turning): 20 days.

Ornamentals (hand harvesting, pruning, thinning, pinching): 20 days.

If re-entry is necessary prior to the designated re-entry intervals, wear cotton overalls buttoned to the neck and wrist (or equivalent clothing) and chemical resistant gloves. Clothing must be laundered after each day's use.

#### PROTECTION OF LIVESTOCK, WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

**CANOLA:** For aerial application to a Canola crop that is directly adjacent to a downwind paddock where grazing stock may be present, use coarse nozzle settings and observe a 20 m buffer to that paddock in order to minimise drift.

DO NOT contaminate streams, rivers or waterways with the chemical or used container or containers which have held treated seed.

DO NOT apply or allow spray to drift onto adjacent non-target aquatic areas (ponds, streams, lakes, rivers and waterways). Allow sufficient buffer distances between downwind non-target water bodies and the sprayed area.

DO NOT apply or allow spray to drift onto adjacent downwind paddock where grazing stock may be present. See 'CRITICAL COMMENTS' in Directions for Use table for specific crop recommendations.

#### STORAGE AND DISPOSAL

# The method of disposal of the container depends on the container type. Read the Storage and Disposal instructions on the label that is attached to the container.

Keep out of reach of children. Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight. Store in a locked room or place away from children, animals, food, feedstuffs, seed and fertilisers.

#### Containers 1 kg

Rinse containers before disposal. Add rinsings to the spray tank. **DO NOT** dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. #### All other non-refillable containers

Triple rinse containers before disposal. Add rinsings to spray tank. **DO NOT** dispose of undiluted chemical on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. **DO NOT** burn empty containers or product. **DO NOT** re-use empty container for any other purpose.

#### **Plastic Bags and Cardboard Containers**

Shake empty bag into spray tank. Single rinse before disposal. Add rinsings to spray tank. **DO NOT** dispose of undiluted chemicals on site. Break, crush or puncture and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. **DO NOT** burn empty bags or product.
